 - You MUST list Krebs Pleasant View Farms, LLC as additional insured and send it to us prior to the event. If emailing this form, send to krebspleasantview@gmail.com prior to August 1st.
- Weather: This is an outdoor event and will be held rain or shine, no rain dates.
- Sales Tax:
 - All artist applications must include a copy of your current Wisconsin Sellers Permit Number.
 - Applicant is responsible for collecting & paying state/county sales tax
 - The permit number will begin with a 456 sales tax or 600 business reporting tax
